SPA# 11-034 The purpose of this state plan amendment is to adjust SFY 2012-2013 rates for Rehabilitation. This state plan change is to adjust the SFY 2012 rates by a negative 2.65% to yield a 12 month, 2% reduction in the 9 remaining months of this SFY. For SFY2013, the rates will be adjusted such that they will equal 98% of the rate in effect July 1, 2011. This state plan change is also to revise state plan language to reflect fee schedule methodology.
