**SPA 11-040 (Family Planning)** - This state plan change allows for services currently provided under the Family Planning Waiver (FPW) covering individuals who are at or below 185% of the federal poverty level, to continue to receive services under a new option. The new option establishes a new eligibility group for the provision of family planning services through an amendment to the Medicaid State Plan.
