This change notice transmits revisions to the EIS Manual. Revisions are effective May 1, 2011, unless noted otherwise.

I. MANUAL SECTION CHANGES

A. Volume I

1. EIS 1061 - REPORT DISTRIBUTION SYSTEM

Added report name "DHREJA PREG MED HOME PROV DIR". (Refer to MA 2301 V1.B2 and MAF 3205 V1.B2 for more info).

Added report name "DHREJA Security-HSMA/HSMD MED EL".

Added report name "DHREJA Security Report".

2. EIS 1105 - STATE DATA EXCHANGE

Link to access the OnLine Verification (OLV) user manual is added.

New codes are added to the Unearned Income Frequency.

Old codes are deleted from the Unearned Income Type.

3. EIS 1107 - STATE ONLINE QUERY/THIRD PARTY QUERY

How to access the State Online Query (SOLQ) is deleted from this section.

4. EIS 1109 - ONLINE VERIFICATION

Mapping information to assist identifying State Online Query (SOLQ), State Data Exchange (SDX), and Beneficiary Data Exchange (BENDEX) field names in OLV is deleted.

The link to the Data Elements for these systems and the Employment Security Commission (ESC) are in this section.

5. EIS 1201 - BROADCAST MESSAGES

Information related to broadcast messages out of IMS/EIS is deleted. Beginning June 1, 2011, the State Office will no longer send broadcast messages via IMS/EIS. All broadcast messages will be sent via listserv over email. Every county must ensure the appropriate staff have subscribed to receive listserv messages prior to June 1, 2011. Refer to EIS 1201 for instructions on how to subscribe.

B. Volume III

1. EIS 3900 - ASSET TRANSFER TRACKING SCREEN

Information regarding the Assets Transfer Tracking Screen has been updated to match Medicaid eligibility policy use of the screen.

The "DHREJA TRANS ASSET EVAL NEEDED" report and the "DHREJA TRANS ASSET EVAL SUMM" report are no longer produced. These reports are no longer needed based on current Medicaid eligibility policy.
